### Categories: 2-DIMENSIONAL and 3-DIMENSIONAL WORKS

- Oil, Acrylic
- Watercolor, Tempura, Gouache, etc.
- Drawing (Pencil, Pastel, Charcoal, Pen & Ink, etc.)
- Photography (must be one of a limited edition)
- 3-Dimensional AND Mixed Media

### Eligibility and Limitations

Open to all residents of Georgia age 18 and older. Work must be original and created by the artist within the last 2 years. Works must not have been exhibited at an AGNWG competition previously. Work completed under the direction of an instructor or in a class is not acceptable. A copy of the original work (Giclee) will not be accepted.

Two dimensional work must be ready to hang with wire. Saw tooth hangers are not acceptable. Works cannot be greater than 40" in width including the frame. No exceptions. Gallery wrapped works need not be framed but must have the sides painted.

All work must be hand delivered and picked up by the artist or his/her representative. Shipped work will not be accepted.

AGNWG retains the right to refuse acceptance of works it deems inappropriate due to content, weight, size or quality of work.

The jurists will make final selection and award decisions.

### Liability

AGNWG and Gallery 4463 will demonstrate reasonable care in handling the artwork. However, neither AGNWG nor Gallery 4463 are responsible for lost, stolen or damaged works. Artists are encouraged to secure their own private insurance coverage.

### Entry Fees

Entrants may submit up to 3 works for consideration. Non member entry fees are \$35 for up to three entries. AGNWG members: \$30 for up to three entries. All fees are non-refundable.

## Images

Images must be submitted via email to Shannon Davidson at [tufty68@gmail.com](mailto:tufty68@gmail.com). (The application and a check or money order made payable to AGNWG can be sent by regular mail to the address listed above.) Image file names must include artist name, title, medium and corresponding entry number from the application form. Example: "LoisSmith\_RunningWater\_Oil\_Entry1.jpg"

Images must be presentation ready. All works will be juried into the show from the images submitted, so they must be high quality. Poorly presented slides showing edges of frames, background, poorly visible images or images which are blurry or not quality representations of the artwork, etc. will not be accepted. Images must be in large RGB/jpeg format. Minimum file size: 500kb. Maximum file size: 5MB. Ideal file size is 1 - 2 MB. Resolution: 150 – 300 dpi.
